MUNICIPAL ORDINANCE NO. 11th-152-2025

AN ORDINANCE AMENDING SECTIONS 6 AND 10.E OF MUNICIPAL ORDINANCE NO. 11TH-04-2022, ENTITLED: "AN ORDINANCE REGULATING THE OPERATION OF TRICYCLES FOR HIRE COMING FROM THE MUNICIPALITIES OF MAHAYAG, TAMBULIG AND RAMON MAGSAYSAY OPERATING OR PLYING WITHIN THE JURISDICTION OF THE MUNICIPALITY OF MOLAVE, PROVINCE OF ZAMBOANGA DEL SUR AND PROVIDING PENALTY FOR VIOLATION THEREOF."

BE IT ORDAINED by the Sangguniang Bayan of Molave, Zamboanga del Sur, in session assembled that:

SECTION 1. PURPOSE. In order to have a clear guideline on where motorized tricycles coming from Ramon Magsaysay, Tambulig and Mahayag, can park in order to prevent unsafe parking and to ensure the security and safety of motorized tricycle commuters, Sections 6 and 10.e of Municipal Ordinance No. 11th-04-2022 which shall read as follows shall be amended:

"SECTION 6. ROUTES. Qualified registered motorized tricycle operators are only allowed to transport their passengers coming from their respective municipalities to their respective destinations and shall park thereafter in their designated area at the playground of Barangay Maloloy-on. They are prohibited to pick up any passengers within the Municipality that is not bound to their route of operation, otherwise they shall be penalized under this ordinance.

SECTION 10. OPERATING CONDITIONS.

e. All tricycles-for-hire when in operation shall display inside the tricycle unit photocopy of the registration of the vehicles operated, the MTP, and driver's license."

SECTION 2. AMENDATORY PROVISION. Sections 6 and 10.e of Municipal Ordinance No. 11th-04-2022 are hereby amended into:

"SECTION 6. ROUTES. Qualified registered motorized tricycle operators are only permitted to transport passengers from their respective municipalities to their designated destinations. Afterward, they must park in the temporary parking area located at the Off-Street Terminal (Barangay Maloloy-on) in front of Aquino Street (formerly Morgan Street). They are prohibited from picking

up passengers within the Municipality who are not bound for their designated route; violations of this provision will result in penalties under Section 22.e. of Municipal Ordinance No. 11th-04-2022.

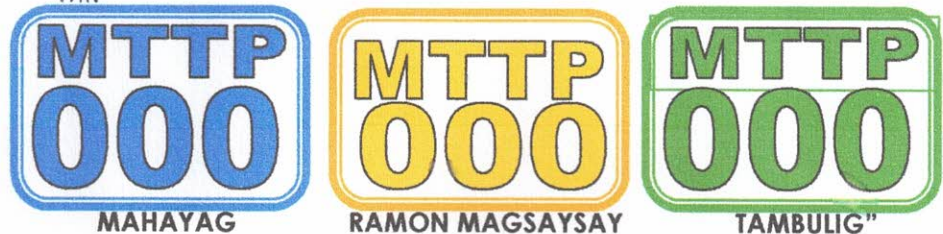
Regulatory Ordinance No. 2016-9th-02 (Traffic Management Code), provides for the designated parking area for passenger of motorized tricycles which is located at the back portion of the previous fruit section, therefore, authorized MTP motorized vehicles are allowed to utilize and park a portion at the back of the Off-Street Terminal as an alternative waiting area.

To ensure an orderly parking system for motorized tricycles in their temporary parking area at the Off-Street Terminal (Barangay Maloloy-on), fronting Aquino Street (formerly Morgan Street), the Local Chief Executive, through the head of the ordinance enforcement unit, shall install appropriate signage designating areas for downtown and inter-municipality routes.

SECTION 10. OPERATING CONDITIONS.

e. All tricycles-for-hire when in operation shall:

- ✓ Display inside the tricycle unit:
 - a photocopy of the registration of the vehicles operated,
 - 2 copies of MTP (the original copy is to be placed fronting the driver's seat while the photocopy is to be posted fronting the commuter's chair), and
 - driver's license.
- ✓ Produce a sticker (containing the designated MTP No.) to be attached at the side of their unit with the corresponding size of 8.27 inches X 11.69 inches (210mm x 297mm), while following the respective colors for different municipalities (white background), to wit:




SECTION 3. PENALTY CLAUSE. Failure to comply the additional condition provided in the amended section shall be a ground for the non-issuance of MTP application form for new applicants and non-renewal or cancellation for old grantees.

SECTION 4. EFFECTIVITY. This ordinance shall take effect immediately upon its approval.
