MUNICIPAL ORDINANCE NO. 11th-153-2025

AN ORDINANCE AMENDING SECTION 9 OF ARTICLE III OF MUNICIPAL ORDINANCE NO. 11TH-25-2023, ENTITLED: "AN ORDINANCE ENACTING THE UPDATED GENDER AND DEVELOPMENT CODE OF MOLAVE, ZAMBOANGA DEL SUR" BY PROVIDING THE COMPOSITION, ROLES AND FUNCTIONS OF THE MUNICIPAL COUNCIL OF WOMEN.

BE IT ORDAINED by the Sangguniang Bayan of Molave, Zamboanga del Sur, that:

SECTION 1. PURPOSE. Section 9 of Article III of Municipal Ordinance No. 11th-25-2023 is read as follows:

"SECTION 9. MUNICIPAL COUNCIL FOR WOMEN. A Municipal Council for Women is hereby created under the Office of the Municipal Mayor in compliance with the provisions of Republic Act No. 7192, otherwise known as Women in Development and Nation Building Act."

SECTION 2. <u>AMENDATORY PROVISIONS.</u> Section 9 of Article III of Municipal Ordinance No. 11th-25-2023 is hereby amended, to read as follows in pursuant to DILG Memorandum Circular No. 2006-125 dated September 21, 2006:

"SECTION 9. COMPOSITION OF THE MUNICIPAL COUNCIL OF WOMEN (MCW). The Council is a non-government entity which shall be comprised of women's organization existing in this municipality and is duly recognized by the LGU. This represents the women GO-NGO partnership in this locality.

The Municipal Council of Women (MCW) shall have nine (9) members of the Board of Trustees: seven (7) from the NGOs/POs/ Professional Groups; one (1) representative from the LGU and one (1) representative from the National Council of Women of the Philippines (NCWP) or its affiliates until such time that there is an organized NCWP in the locality.

The MCW of this municipality is hereby created and shall be composed of the following Board of Trustees:

- LGU Representative (Focal Person for Women);

- Seven (7) from the NGOs/POs/Professional Groups/Religious Organization led by women

The members of the Board shall elect from among themselves the regular Chairperson and other officers such as: Vice Chairperson, Secretary, Assistant Secretary, Treasurer, Assistant Treasurer, Auditor, PRO and other officers that may be created as the needs arises. The LGU representatives cannot be elected as Chairperson.

The LGU through one (1) of the seven (7) women's association's representatives, including the LGU representatives (MSWDO and SB, Committee on Social Services, Women and Family Welfare) shall convene all women NGOs to organize the MCW.

SECTION 9.a. <u>**TERM OF OFFICE**</u>. The term of office of the MCW shall be for two (2) years.

SECTION 9.b. ACCREDITATION OF THE MUNICIPAL COUNCIL OF WOMEN. The Municipal Council of Women must apply for the accreditation to the Philippine Federation of Local Council of Women (PFLCW), Inc. subject to the accreditation and membership guidelines set by the PFLCW.

SECTION 9.c. ROLES AND FUNCTIONS OF THE MUNICIPAL COUNCIL OF WOMEN. As vehicle in mainstreaming GAD in pursuit of women empowerment, gender equality, social justice, lasting peace, fulfillment and protection of human rights, and sustainable development, the Municipal Council of Women, shall:

- Define their respective advocacy agenda which shall incorporate their local priorities in terms of local, national, international women's agenda, to include, but not limited to the following:
 - a. The implementation of international and national instruments such as Convention of the Elimination of all Forms of Discrimination Against Women (CEDAW); Beijing Platform for Action (BPFA); the Philippine Plan for Gender Responsive Development (PPGD); and the Framework Plan for Women among their networks;
 - Mainstreaming of gender and development in the LGU, and the passage of local legislation addressing gender issues and women's concerns;
 - c. Formulation of the LGUs GAD Plan and Budget;
 - Participation of women in local governance by pushing for passage of the bill on Sectoral Representation to the Local Sanggunian and ensuring representation of women in local special bodies, among others;
- Support the implementation of the Framework Plan for Women by collaborating with government agencies and/or GAD Focal Points for the implementation of GAD related programs, projects and activities (PPAs) and developing and implementing projects that address gender issues and women's concerns;
- 3. Undertake activities and projects such as livelihood, micro-enterprise, social services and training and skills development, within the framework of GAD particularly, the Framework Plan for Women,

independently or in partnership with existing Local Councils and other government agencies;

- 4. Establish linkage with business sector, GO and NGO institutions to enable women's access to resources, information and technology, in order to pursue its projects more effectively;
- 5. Monitor the implementation and impact of local policies and programs on women and provide the local machineries on women, the Local Chief Executive, and other relevant agencies with copies of the findings, and ensure corresponding action;
- 6. Establish linkage with the NCRFW in the pursuit of gender and development mainstreaming and women empowerment at the local level; and
- 7. Build the entrepreneurial capability of marginalized women locally, nationally and internationally. "

SECTION 3. <u>**REPEALING CLAUSE.**</u> Any ordinance which is inconsistent with the provisions of this ordinance is hereby repealed.

SECTION 4. EFFECTIVITY. This ordinance shall take effect immediately upon its approval.

The committee meeting started at 10:49 in the morning.

The Chairman presented Draft Ordinance No. 203 - AN ORDINANCE AMENDING SECTION 9 OF ARTICLE III OF MUNICIPAL ORDINANCE NO. 11TH-25-2023, ENTITLED: "AN ORDINANCE ENACTING THE UPDATED GENDER AND DEVELOPMENT CODE OF MOLAVE, ZAMBOANGA DEL SUR" BY PROVIDING THE COMPOSITION, ROLES AND FUNCTIONS OF THE MUNICIPAL COUNCIL FOR WOMEN.

The Chairman highlighted that Draft Ordinance No. 203, focuses on strengthening the Municipal Council for Women (MCW) in Molave, Zamboanga del Sur, by amending Section 9 of Article III of Municipal Ordinance No. 11th-25-2023, which originally established the MCW. The ordinance aims to enhance the MCW's composition, roles, and functions to better promote gender equality, women's empowerment, and sustainable development within the municipality. That the creation of the MCW is mandated by Republic Act No. 7192, the Women in Development and Nation Building Act, which underscores the government's commitment to promoting women's rights and participation in all aspects of development. This ordinance fulfills this legal obligation and strenathens the MCW's foundation.

The Chairman then cited Section 9 of Article III of Municipal Ordinance No. 11th. 25-2023, which read as follows:

SECTION 9. MUNICIPAL COUNCIL FOR WOMEN. A Municipal Council for Women is hereby created under the Office of the Municipal Mayor in compliance with the provisions of Republic Act No. 7192, otherwise known as Women in Development and Nation Building Act.

The Chairman emphasized that Section 9 of Article III of Municipal Ordinance No. 11th-25-2023 will be amended, to read as follows:

Justification/Remarks
