A RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR, HON. CYRIL REO A. GLEPA, M.D., TO ENTER INTO AND SIGN A CONTRACT OF SERVICE WITH MS. ANA CRISTBELLE C. HELIDO AS THE MUNICIPALITY'S OFFICIAL CANDIDATE TO THE MISS ZAMBOANGA DEL SUR – PROVINCIAL GOVERNMENT COLLEGE (PGC) PAGEANT IN RELATION TO THE 74th ARAW NG ZAMBOANGA DEL SUR CELEBRATION.

WHEREAS, the Province of Zamboanga del Sur will celebrate its 74th Araw ng Zamboanga del Sur, featuring various programs, activities, and competitions intended to promote the province's culture, talents, beauty, creativity, unity, and community participation;

WHEREAS, the Local Government Unit of Molave recognizes the importance of actively participating in the said celebration and showcasing the talents, beauty, skills, and personality of its constituents in various provincial activities;

WHEREAS, one of the major activities in connection with the celebration is the Miss Zamboanga del Sur – Provincial Government College (PGC) Pageant, wherein the Municipality of Molave shall participate through an official candidate;

WHEREAS, Ms. Ana Cristbelle C. Helido has been identified and evaluated as qualified and capable of representing the Municipality of Molave as its official candidate in the said pageant, considering her qualifications, personality, skills, and capacity to undertake the responsibilities required of an official candidate;

WHEREAS, the engagement of Ms. Ana Cristbelle C. Helido is necessary to ensure the proper and effective representation of the Municipality of Molave in the said pageant and to promote the Municipality's local identity, talents, beauty, and community pride during the 74th Araw ng Zamboanga del Sur celebration;

WHEREAS, during deliberation, the august body reviewed the proposed Contract of Service (COS) and identified the appropriate duties, responsibilities, terms, and conditions to be undertaken by both parties to be in order, reasonable, and consistent with the objectives and requirements of the Municipality's participation in the Miss Zamboanga del Sur – PGC Pageant, subject to existing laws, rules, regulations, and applicable accounting and auditing requirements;

WHEREAS, the engagement of the Municipality's official candidate will contribute to the promotion of local talent, beauty, confidence, and community pride and will provide meaningful representation of the Municipality of Molave in the provincial celebration;

NOW, THEREFORE, on motion of Honorable Orbita and duly seconded by Honorable Uy, the Sangguniang Bayan of Molave, Zamboanga del Sur, hereby;

RESOLVED, as it is hereby resolved to authorize the Municipal Mayor, Hon. Cyrii Reo A. Glepa, M.D., to enter into and sign a Contract of Service with Ms. Ana Cristbelle C. Helido as the Municipality's Official Candidate to the Miss Zamboanga del Sur – Provincial Government College (PGC) Pageant in relation to the 74th Araw ng Zamboanga del Sur Celebration.

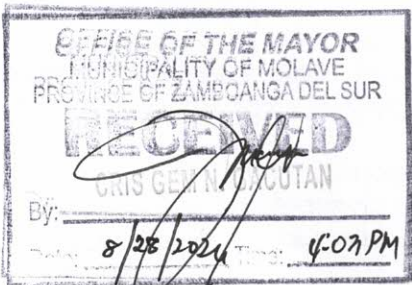
