RESOLUTION NO. 12th-490-2026

A RESOLUTION ADOPTING AND SUPPORTING PROVINCIAL ORDINANCE NO. 12th-056-2026, ENTITLED: "AN ORDINANCE PROHIBITING THE SELLING AND ACCESS OF MINORS OR PERSON BELOW EIGHTEEN (18) YEARS OF AGE TO ALCOHOLIC BEVERAGES AND LIQUORS, PENALIZING ANY PERSON OR PERSONS AND ESTABLISHMENTS FROM SELLING AND DISPENSING ALCOHOLIC BEVERAGES AND LIQUORS INCLUDING THE SERVING AND DRINKING IN PUBLIC PLACES, WITHIN THE PROVINCE OF ZAMBOANGA DEL SUR.

WHEREAS, the Sangguniang Panlalawigan of Zamboanga del Sur enacted Provincial Ordinance No. 12th-056-2026 on July 9, 2026, providing measures to protect persons below eighteen (18) years of age from the harmful effects of alcoholic beverages and to regulate their sale, furnishing, dispensing, serving, and consumption in public places;

WHEREAS, the said Provincial Ordinance seeks to strengthen the protection of minors by requiring establishments selling alcoholic beverages to observe appropriate safeguards, including age verification, posting of notices, and coordination with law enforcement authorities for its proper implementation;

WHEREAS, the Municipality of Molave recognizes the importance of protecting children and minors from the harmful effects of alcohol and promoting public order, safety, health, and welfare within its territorial jurisdiction;

WHEREAS, the Sangguniang Bayan previously enacted Municipal Regulatory Ordinance No. 2002-06, entitled "Prohibiting Any Minor Below 18 Years Old from Drinking Intoxicating Liquors Within the Jurisdiction of the Municipality of Molave, Zamboanga del Sur," which principally prohibits minors below eighteen (18) years of age from drinking intoxicating liquors and similar beverages;

WHEREAS, considering the passage of Provincial Ordinance No. 12th-056-2026 and the developments in the applicable legal and regulatory framework, there is a need to strengthen and update the existing municipal policy by addressing not only the consumption of alcoholic beverages by minors but also the selling, furnishing, dispensing, serving, giving, or otherwise providing alcoholic beverages to persons below eighteen (18) years of age;

WHEREAS, the Committee after review and deliberation, found the objectives and provisions of the Provincial Ordinance to be consistent with the general welfare and public safety objectives of the Municipality;

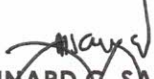
WHEREAS, the Committee further recommended the adoption and support of Provincial Ordinance No. 12th-056-2026 and the formulation of an appropriate municipal ordinance incorporating its relevant provisions, consistent with Republic Act No. 7160, Republic Act No. 9344, as amended by Republic Act No. 10630, and other applicable national laws, rules, and regulations;

NOW, THEREFORE, on motion of Honorable Cabasag and duly seconded by Honorable Salinas, the Sangguniang Bayan of Molave, Zamboanga del Sur, hereby;

RESOLVED, as it is hereby resolved to adopt and support Provincial Ordinance No. 12th-056-2026, entitled: "An ordinance prohibiting the selling and access of minors or person below eighteen (18) years of age to alcoholic beverages and liquors, penalizing any person or persons and establishments from selling and dispensing alcoholic beverages and liquors including the serving and drinking in public places, within the Province of Zamboanga del Sur.

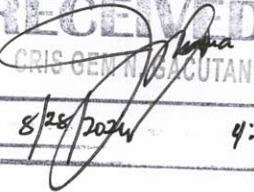

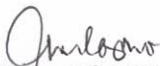
