A RESOLUTION REQUESTING THE LOCAL HEALTH BOARD OF THE MUNICIPALITY OF MOLAVE, ZAMBOANGA DEL SUR, TO TRANSMIT FUTURE RESOLUTIONS TO THE SANGGUNIANG BAYAN TOGETHER WITH COMPLETE SUPPORTING DOCUMENTS AND ANNEXES NECESSARY FOR PROPER LEGISLATIVE REVIEW AND APPROPRIATE ACTION.

WHEREAS, the Sangguniang Bayan received a copy of Local Health Board Resolution No. 2025-010, entitled "A Resolution Approving the List of Registered and Accredited Barangay Health Workers Presented and Submitted to the Local Health Board by the Local Health Board-Registration and Accreditation Committee";

WHEREAS, the said Resolution was adopted by the Local Health Board during its Last Quarter Meeting held on November 10, 2025, after deliberation and evaluation of the applications for registration and accreditation of Barangay Health Workers (BHWs);

WHEREAS, upon review of Local Health Board Resolution No. 2025-010, the Sangguniang Bayan noted that the approved List of Registered and Accredited Barangay Health Workers, which forms an integral part of the said Resolution and is necessary for complete evaluation and appropriate legislative consideration, was not attached to the copy transmitted to the Sanggunian;

WHEREAS, the Sangguniang Bayan recognizes the importance of complete and timely submission of legislative documents, including all relevant attachments, annexes, and supporting records, to ensure proper review, informed decision-making, transparency, and effective coordination between local government offices and concerned local special bodies;

WHEREAS, the Sangguniang Bayan likewise acknowledges the continuing cooperation of the Local Health Board in matters concerning public health governance and recognizes the need for an efficient mechanism for the proper documentation and transmittal of official issuances requiring legislative action;

NOW, THEREFORE, on motion of Honorable Geromo and duly seconded by Honorable Uy, the Sangguniang Bayan of Molave, Zamboanga del Sur, hereby;

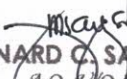

UNANIMOUSLY APPROVED, this 21st day of July, 2026 at Barangay Dontulan, Molave, Zamboanga del Sur.

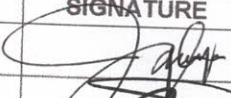
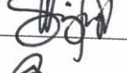
