RESOLUTION NO. 12th-443-2026

A RESOLUTION APPROVING THE REALIGNMENT OF FUNDS IN THE AMOUNT OF THREE MILLION PESOS (P3,000,000.00) FROM THE CONSTRUCTION OF THE SOLID WASTE PROCESSING CENTER PROJECT UNDER THE 20% DEVELOPMENT FUND FOR CALENDAR YEAR 2019 TO THE SUPPLY, DELIVERY, AND INSTALLATION OF A CLOSED-CIRCUIT TELEVISION (CCTV) SYSTEM AT THE NEW PUBLIC MARKET OF THE MUNICIPALITY OF MOLAVE, ZAMBOANGA DEL SUR, PURSUANT TO MDC RESOLUTION NO. 9, SERIES OF 2026.

WHEREAS, the Municipality of Molave recognizes the need to continuously enhance public safety, maintain peace and order, and provide a secure environment for residents, vendors, consumers, and visitors, particularly within the New Public Market, which serves as one of the Municipality's principal centers of commerce and public activity;

WHEREAS, the installation of a Closed-Circuit Television (CCTV) System is a proactive measure that will strengthen surveillance and monitoring capabilities, deter criminal activities, facilitate the investigation of incidents, improve traffic and crowd management, and promote greater accountability in the conduct of commercial and public transactions within the market premises;

WHEREAS, the Municipal Development Council (MDC), after evaluating the Municipality's current development priorities during its regular meeting held on July 6, 2026, adopted MDC Resolution No. 9, Series of 2026, recommending the realignment of funds in the amount of Three Million Pesos (P3,000,000.00) from the Construction of the Solid Waste Processing Center Project under the 20% Development Fund for Calendar Year 2019 to the Supply, Delivery, and Installation of a Closed-Circuit Television (CCTV) System at the New Public Market of the Municipality of Molave, Zamboanga del Sur;

WHEREAS, the amount appropriated for the Construction of the Solid Waste Processing Center Project has remained unutilized and may be considered for realignment, subject to compliance with the applicable provisions of the Local Government Code of 1991 and the pertinent budgeting, accounting, and auditing rules and regulations;

WHEREAS, the Municipal Mayor thereafter endorsed the recommendation of the Municipal Development Council to the Sangguniang Bayan for its legislative consideration and approval, recognizing that the proposed project responds to the Municipality's present needs and priorities;

WHEREAS, upon review of the recommendation of the Municipal Development Council and the report of the appropriate committee, the Sangguniang Bayan finds that the proposed realignment will promote the efficient and responsive utilization of public funds by supporting a project that directly contributes to public safety, protects municipal assets, and advances the welfare of the constituents of Molave;

NOW, THEREFORE, on motion of Honorable Salinas and duly seconded by Honorable Uy, the Sangguniang Bayan of Molave, Zamboanga del Sur, hereby;

RESOLVED, as it is hereby resolved to approving the Realignment of Funds in the amount of Three Million Pesos (P3,000,000.00) from the Construction of the Solid Waste Processing Center Project under the 20% Development Fund for Calendar Year 2019 to the Supply, Delivery, and Installation of a Closed-Circuit Television (CCTV) System at the New Public Market of the Municipality of Molave, Zamboanga del Sur, pursuant to MDC Resolution No. 9, Series of 2026.

UNANIMOUSLY APPROVED, this 21st day of July, 2026 at Barangay Dontulan, Molave, Zamboanga del Sur.

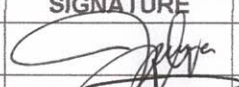
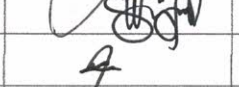
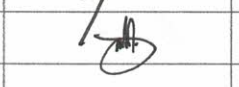
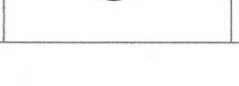
