



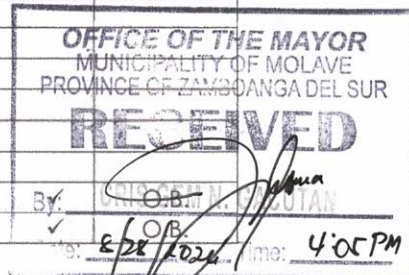

RESOLUTION NO. 12th-489-2026

A RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR, HON. CYRIL REO A. GLEPA, M.D., TO ENTER INTO AND SIGN A CONTRACT OF SERVICE WITH MR. JEMSON ALBERT P. ALCORIN, HANDLER AND WARDROBE STYLIST FOR THE MUNICIPALITY'S CANDIDATES FOR THE MR. & MISS ZAMBOANGA DEL SUR-PROVINCIAL GOVERNMENT COLLEGE PAGEANT, IN RELATION TO THE 74TH ARAW NG ZAMBOANGA DEL SUR CELEBRATION.

WHEREAS, the Province of Zamboanga del Sur will celebrate its 74th Araw ng Zamboanga del Sur, featuring various activities and competitions that promote the talents, skills, culture, and unity of its component local government units;

WHEREAS, the Municipality of Molave shall participate in the Mr. & Miss Zamboanga del Sur – Provincial Government College (PGC) Pageant through its official candidates as part of the said provincial celebration;

WHEREAS, the Municipality's participation requires specialized services for the proper handling, wardrobe preparation, styling, coordination, and overall supervision of the candidates during rehearsals, exposures, and other pageant-related activities;

WHEREAS, Mr. Jemson Albert P. Alcorin has been identified and evaluated as qualified and capable of providing the necessary services as Handler and Wardrobe Stylist for the Municipality's candidates;

WHEREAS, as Handler and Wardrobe Stylist, Mr. Alcorin shall, among others, provide and coordinate the outfits and costumes required for the candidates' various exposures, ensure that the candidates are appropriately dressed in accordance with the pageant guidelines, provide the necessary accessories, assist in their pre-pageant preparations, accompany them during rehearsals and pre-pageant activities, and coordinate with the Provincial Government and other concerned organizers together with the Municipal Tourism Officer;

WHEREAS, during deliberation, the august body reviewed the proposed Contract of Service (COS), including the duties and responsibilities of both parties, and found its provisions, terms, and conditions to be in order and appropriate to the Municipality's participation in the said pageant;

WHEREAS, in consideration of the services to be rendered, the Municipality shall pay Mr. Alcorin the amount of ONE HUNDRED SEVENTY-FIVE THOUSAND PESOS (P175,000.00), payable in accordance with the terms of the Contract of Service and subject to compliance with applicable accounting, auditing, and other government requirements;

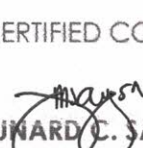
WHEREAS, the engagement of a qualified Handler and Wardrobe Stylist is necessary to ensure the proper preparation and effective representation of the Municipality's candidates and to enhance the Municipality's participation in the Mr. & Miss Zamboanga del Sur – PGC Pageant;

NOW, THEREFORE, on motion of Honorable Orbita and duly seconded by Honorable Uy, the Sangguniang Bayan of Molave, Zamboanga del Sur, hereby;

RESOLVED, as it is hereby resolved to authorize the Municipal Mayor, Hon. Cyril Reo A. Glepa, M.D., to enter into and sign a Contract of Service with Mr. Jemson Albert P. Alcorin, Handler and Wardrobe Stylist for the municipality's candidates for the Mr. & Miss Zamboanga del Sur-Provincial Government College Pageant, in relation to the 74th Araw ng Zamboanga del Sur celebration.

UNANIMOUSLY APPROVED, this 25th day of August, 2026 at Molave, Zamboanga del Sur.

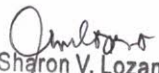
