RESOLUTION NO. 12th-439-2026

A RESOLUTION DECLARING VALID AND OPERATIVE IN ITS ENTIRETY APPROPRIATION ORDINANCE NO. 2 SERIES 2026 OF BARANGAY MABUHAY, TITLED: "AN ORDINANCE APPROPRIATING THE AMOUNT OF ONE HUNDRED TWENTY THOUSAND PESOS (P120,000.00) FOR THE VARIOUS EXPENDITURE OF BARANGAY MABUHAY, MOLAVE, ZAMBOANGA DEL SUR AS PER SUPPLEMENTAL BUDGET NO. 2, CY 2026."

WHEREAS, Section 57 of the Republic Act No. 7160, otherwise known as the Local Government Code of 1991, provides that barangay ordinances enacted by the Sangguniang Barangay shall be submitted to the Sangguniang Bayan for review as to whether the same are consistent with law and municipal ordinances;

WHEREAS, the Sangguniang Barangay of Barangay Mabuhay submitted for review Appropriation Ordinance No. 2 Series 2026 of Barangay Mabuhay, titled: "AN ORDINANCE APPROPRIATING THE AMOUNT OF ONE HUNDRED TWENTY THOUSAND PESOS (P120,000.00) FOR THE VARIOUS EXPENDITURE OF BARANGAY MABUHAY, MOLAVE, ZAMBOANGA DEL SUR AS PER SUPPLEMENTAL BUDGET NO. 2, CY 2026;

WHEREAS, the Supplemental Budget No. 2, CY 2026 of Barangay Mabuhay is supported with the following requirements:

- a. BDC Resolution No. 3, S-2026 – A resolution recommending the approval of Supplemental Annual Investment Program No. 2 for Calendar Year 2026 of Barangay Mabuhay, Molave, Zamboanga del Sur.
- b. Resolution No. 10, Series of 2026 – A resolution validating BDC Resolution No. 3, Series of 2026.
- c. Appropriation Ordinance No. 2, Series 2026 - "AN ORDINANCE APPROPRIATING THE AMOUNT OF ONE HUNDRED TWENTY THOUSAND PESOS (P120,000.00) FOR THE VARIOUS EXPENDITURE OF BARANGAY MABUHAY, MOLAVE, ZAMBOANG DEL SUR AS PER SUPPLEMENTAL BUDGET NO. 2, CY 2026."
