RESOLUTION NO. 12th-441-2026

A RESOLUTION DECLARING VALID AND OPERATIVE IN ITS ENTIRETY APPROPRIATION ORDINANCE NO. 01, S-2025 OF BARANGAY SILANGIT, MUNICIPALITY OF MOLAVE, PROVINCE OF ZAMBOANGA DEL SUR, ENTITLED: "AN ORDINANCE PROGRAMMING APPROPRIATIONS AND REGULATING THE VARIOUS EXPENDITURES IN THE GENERAL FUND IN THE TOTAL AMOUNT OF THREE MILLION TWO HUNDRED SEVENTY-NINE THOUSAND FIVE HUNDRED TWENTY-SEVEN PESOS AND 13/100 (P3,279,527.13) FOR FY 2026 OF BARANGAY SILANGIT, MOLAVE, ZAMBOANGA DEL SUR."

WHEREAS, Section 305 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, provides that local government units shall formulate sound financial plans and that their financial affairs, transactions, and operations shall be governed by the principles of accountability, transparency, and fiscal responsibility;

WHEREAS, pursuant to Section 447 of the Local Government Code of 1991, the Sangguniang Bayan exercises legislative powers necessary for the effective governance of the municipality, including the review of ordinances enacted by component barangays within its territorial jurisdiction in accordance with existing laws, rules, and regulations;

WHEREAS, Barangay Silangit enacted Appropriation Ordinance No. 01, S-2025, programming appropriations and regulating expenditures from its General Fund for Fiscal Year 2026 in the total amount of Three Million Two Hundred Seventy-Nine Thousand Five Hundred Twenty-Seven Pesos and 13/100 (P3,279,527.13);

WHEREAS, the estimated resources of Barangay Silangit for Fiscal Year 2026 are derived from its share in Real Property Tax amounting to Forty-Three Thousand Three Hundred One Pesos and 13/100 (P43,301.13), non-tax revenues from clearances and certificates amounting to Seven Hundred Pesos (P700.00), subsidy from the Local Government Unit amounting to One Thousand Pesos (P1,000.00), and National Tax Allotment amounting to Three Million Two Hundred Thirty-Four Thousand Five Hundred Twenty-Six Pesos (P3,234,526.00), for a total available resource of P3,279,527.13;

WHEREAS, the total appropriations under the said ordinance are allocated for Personal Services, Maintenance and Other Operating Expenses, Capital Outlay, Sangguniang Kabataan appropriations, Barangay Development Fund, Barangay Disaster Risk Reduction and Management Fund, Gender and Development Fund, and other mandatory allocations, consistent with applicable laws, rules, and regulations governing barangay budgeting;

WHEREAS, upon review and evaluation by the Committee it was determined that Appropriation Ordinance No. 01, S-2025 of Barangay Silangit complies with the budgetary requirements, limitations, and mandatory expenditure allocations prescribed by existing laws, rules, and regulations;

WHEREAS, the august body adopted the committee's recommendations and found that the total appropriations are fully supported by the estimated available resources of Barangay Silangit, resulting in no unappropriated balance, and that the annual budget promotes the efficient delivery of basic services and implementation of priority programs of the barangay;

NOW, THEREFORE, on motion of Honorable Salinas and duly seconded by Honorable Perong, the Sangguniang Bayan of Molave, Zamboanga del Sur, hereby;

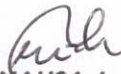
RESOLVED, as it is hereby resolved to declare valid and operative in its entirety Appropriation Ordinance No. 01, S-2025 of Barangay Silangit, Municipality of Molave, Province of Zamboanga del Sur, entitled: "An ordinance programming appropriations and regulating the various expenditures in the General Fund in the total amount of Three Million Two Hundred Seventy-Nine Thousand Five Hundred Twenty-Seven Pesos and 13/100 (P3,279,527.13) for FY 2026 of Barangay Silangit, Molave, Zamboanga del Sur."
