A RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR, HON. CYRIL REO A. GLEPA, M.D., TO ENTER INTO AND SIGN A CONTRACT OF SERVICE WITH MS. MARYROSE M. MARCELLANA AS OFFICIAL REPRESENTATIVE FOR ZAMBOSUPERSTARS SINGING COMPETITION SEASON 5 ZDS PGC EDITION IN RELATION TO THE 74TH ARAW NG ZAMBOANGA DEL SUR CELEBRATION.

WHEREAS, the Province of Zamboanga del Sur will celebrate its 74th Araw ng Zamboanga del Sur, featuring various activities and competitions intended to promote the province's culture, talents, unity, sportsmanship, and community participation;

WHEREAS, the Local Government Unit of Molave recognizes the importance of actively participating in the said celebration and showcasing the talents and skills of its constituent in various provincial activities and competitions;

WHEREAS, one of the activities lined up for the celebration is the ZamboSuperstars Singing Competition Season 5 – ZDS PGC Edition, wherein the Municipality of Molave intends to participate through an official representative;

WHEREAS, Ms. Maryrose M. Marcellana has been identified and evaluated as qualified and capable of representing the Municipality of Molave in the said singing competition, considering her skills, talent, experience, and capacity to undertake the responsibilities required of an official representative;

WHEREAS, the engagement of an official representative is necessary to ensure the proper and effective representation of the Municipality of Molave in the ZamboSuperstars Singing Competition Season 5 – ZDS PGC Edition and to promote the Municipality's local talent and cultural identity during the 74th Araw ng Zamboanga del Sur celebration;

WHEREAS, during deliberation, the august body reviewed and identified the appropriate obligations and responsibilities of both parties as contained in the pro forma Contract of Service (COS), including the services to be rendered by the Second Party and the corresponding obligations of the Local Government Unit;

WHEREAS, the provisions, terms, and conditions of the proposed Contract of Service have been reviewed and found to be in order, reasonable, and consistent with the objectives and requirements of the Municipality's participation in the ZamboSuperstars Singing Competition Season 5 – ZDS PGC Edition, subject to existing laws, rules, regulations, and applicable accounting and auditing requirements;

WHEREAS, the engagement of Ms. Maryrose M. Marcellana will contribute to the effective representation of the Municipality of Molave and the promotion of local talent, artistry, and community pride during the provincial celebration;

NOW, THEREFORE, on motion of Honorable Orbita and duly seconded by Honorable Uy, the Sangguniang Bayan of Molave, Zamboanga del Sur, hereby;

RESOLVED, as it is hereby resolved to authorize the Municipal Mayor, Hon. Cyril Reo A. Glepa, M.D., to enter into and sign a Contract of Service with Ms. Maryrose M.
