RESOLUTION NO. 12th-442-2026

A RESOLUTION APPROVING THE REALIGNMENT OF FUNDS IN THE AMOUNT OF TWO MILLION NINE HUNDRED THOUSAND PESOS (P2,900,000.00), FROM THE CONSTRUCTION OF A RIPRAP AT PUROK CENTRO, BARANGAY DALAON, UNDER SUPPLEMENTAL BUDGET NO. 2, FISCAL YEAR 2026, TO THE CONSTRUCTION OF A FARM-TO-MARKET ROAD AT PUROK CENTRO, BARANGAY DALAON, MUNICIPALITY OF MOLAVE, ZAMBOANGA DEL SUR, PURSUANT TO MDC RESOLUTION NO. 8, SERIES OF 2026.

WHEREAS, the Municipal Development Council (MDC), being the primary planning and policy-making body for the development concerns of the municipality-deliberated upon and approved the proposed realignment of funds in the amount of Two Million Nine Hundred Thousand Pesos (P2,900,000.00) from the Construction of a Riprap at Purok Centro, Barangay Dalaon, to the Construction of a Farm-to-Market Road at the same location;

WHEREAS, the MDC determined that the construction of a Farm-to-Market Road at Purok Centro, Barangay Dalaon, has become the more urgent and responsive infrastructure priority considering its direct contribution to improving access to agricultural production areas, facilitating the efficient transport of farm produce, reducing transportation costs, and enhancing the livelihood opportunities of farmers and residents of the community;

WHEREAS, the Municipal Mayor transmitted to the Sangguniang Bayan MDC Resolution No. 8, Series of 2026, recommending the approval of the realignment of funds for appropriate legislative action;

WHEREAS, the Committee, after reviewing the request and supporting documents, found that the proposed realignment is consistent with the Municipality's development priorities and promotes the judicious, efficient, and economical utilization of public funds by directing available resources to a project expected to yield greater and more immediate socio-economic benefits;

WHEREAS, under the pertinent provisions of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, the Sangguniang Bayan is vested with the authority to approve appropriations and authorize budgetary measures necessary to implement approved local development programs and projects, subject to existing budgeting, accounting, and auditing laws, rules, and regulations;

WHEREAS, the Sangguniang Bayan finds merits in the recommendation of the Committee and is satisfied that the proposed realignment is consistent with the

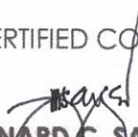
development priorities of the Municipal Government of Molave and serves the best interest of its constituents;

NOW, THEREFORE, on motion of Honorable Salinas and duly seconded by Honorable Uy, the Sangguniang Bayan of Molave, Zamboanga del Sur, hereby;

RESOLVED, as it is hereby resolved to approve the realignment of funds in the amount of Two Million Nine Hundred Thousand pesos (P2,900,000.00), from the Construction of a Riprap at Purok Centro, Barangay Dalaon, under Supplemental Budget No. 2, Fiscal Year 2026, to the Construction of a Farm-to-Market Road at Purok Centro, Barangay Dalaon, Municipality of Molave, Zamboanga del Sur, pursuant to MDC Resolution No. 8, Series of 2026.

UNANIMOUSLY APPROVED, this 21st day of July, 2026 at Barangay Dontulan, Molave, Zamboanga del Sur.
