A RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR, HON. CYRIL REO A. GLEPA, M.D., TO DONATE AND TRANSFER ONE (1) SOUND SYSTEM TO THE ZAMBOANGA DEL SUR PROVINCIAL GOVERNMENT COLLEGE (ZDSPGC)–MOLAVE CAMPUS, THROUGH ITS CAMPUS ADMINISTRATOR, MS. REGINA O. MENIORIA, AS REFLECTED IN THE CORRESPONDING PROPERTY TRANSFER REPORT.

WHEREAS, Section 16 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, empowers local government units to promote the general welfare through measures that enhance the delivery of public services and support institutions that contribute to the welfare of their constituents;

WHEREAS, Sections 22 and 444 of the Local Government Code authorize the Municipal Mayor to enter into contracts and dispose of municipal property upon authority of the Sangguniang Bayan, in accordance with existing laws, rules, and regulations;

WHEREAS, the Municipal Government of Molave intends to donate and transfer one (1) sound system to the Zamboanga del Sur Provincial Government College (ZDSPGC)–Molave Campus to support its academic, cultural, extension, and community engagement programs and activities;

WHEREAS, the subject property is covered by the corresponding Property Transfer Report (PTR), has been duly accounted for by the Municipal Government, and is available for transfer in accordance with applicable government accounting, auditing, and property management rules and regulations;

WHEREAS, the transfer will ensure that the property is properly recorded under the books of the recipient institution, thereby relieving the Municipal Government of accountability over the property while maintaining accurate government property and inventory records in accordance with applicable Commission on Audit (COA) regulations;

WHEREAS, the august body found the proposed donation and transfer to be in order and recommended its approval.

NOW, THEREFORE, on motion of Honorable Perong and duly seconded by Honorable Salinas, the Sangguniang Bayan of Molave, Zamboanga del Sur, hereby;

RESOLVED, as it is hereby resolved to authorize the Municipal Mayor, Hon. Cyril Reo A. Glepa, M.D., to donate and transfer One (1) sound system to the Zamboanga del Sur Provincial Government College (ZDSPGC)-Molave Campus, through its Campus Administrator, Ms. Regina O. Meniora, as reflected in the corresponding property transfer report.
