A RESOLUTION DECLARING VALID AND OPERATIVE IN ITS ENTIRETY APPROPRIATION ORDINANCE NO. 1 SERIES OF 2026 OF BARANGAY DALAON, TITLED: "AN ORDINANCE APPROPRIATING AN AMOUNT OF FOUR HUNDRED SEVEN THOUSAND ONE HUNDRED FIFTY-SIX PESOS AND EIGHTY-FOUR CENTAVOS (PHP407,156.84) INTENDED FOR THE VARIOUS EXPENDITURES IN THE GENERAL FUND FOR CY 2026 OF BARANGAY DALAON, MOLAVE, ZAMBOANGA DEL SUR AS PER SUPPLEMENTAL BUDGET NO. 1 SERIES OF 2026."

WHEREAS, Section 57 of the Republic Act No. 7160, otherwise known as the Local Government Code of 1991, provides that barangay ordinances enacted by the Sangguniang Barangay shall be submitted to the Sangguniang Bayan for review as to whether the same are consistent with law and municipal ordinances;

WHEREAS, the Sangguniang Barangay of Barangay Dalaon submitted for review Appropriation Ordinance No. 1 Series of 2026 of Barangay Dalaon, titled: "AN ORDINANCE APPROPRIATING AN AMOUNT OF FOUR HUNDRED SEVEN THOUSAND ONE HUNDRED FIFTY-SIX PESOS AND EIGHTY-FOUR CENTAVOS (PHP407,156.84) INTENDED FOR THE VARIOUS EXPENDITURES IN THE GENERAL FUND FOR CY 2026 OF BARANGAY DALAON, MOLAVE, ZAMBOANGA DEL SUR AS PER SUPPLEMENTAL BUDGET NO. 1 SERIES OF 2026;

- Appropriation Ordinance No. 1 Series of 2026 - AN ORDINANCE APPROPRIATING AN AMOUNT OF FOUR HUNDRED SEVEN THOUSAND ONE HUNDRED FIFTY-SIX PESOS AND EIGHTY-FOUR CENTAVOS (PHP407,156.84) INTENDED FOR THE VARIOUS EXPENDITURES IN THE GENERAL FUND FOR CY 2026 OF BARANGAY DALAON, MOLAVE, ZAMBOANGA DEL SUR AS PER SUPPLEMENTAL BUDGET NO. 1 SERIES OF 2026.

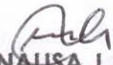
