RESOLUTION NO. 12th-446-2026

A RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR, HON. CYRIL REO A. GLEPA, M.D., TO ENTER INTO AND SIGN A MEMORANDUM OF AGREEMENT BETWEEN THE MUNICIPAL GOVERNMENT OF MOLAVE, AS THE IMPLEMENTING AGENCY, AND BARANGAY BAG-ONG ARGAO, REPRESENTED BY ITS PUNONG BARANGAY, HON. MARISSA A. PANTINOPLE, AS THE SOURCE AGENCY, FOR THE PROCUREMENT AND INSTALLATION OF ONE (1) UNIT OF 15 KVA TRANSFORMER FOR THE BARANGAY WATER SYSTEM PROJECT, THEREBY SUPERSEDING RESOLUTION NO. 12TH-370-2026.

WHEREAS, Section 16 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, vests local government units with the authority to exercise powers necessary, appropriate, or incidental to their efficient and effective governance and to promote the general welfare of their inhabitants, including the implementation of programs and projects that improve the delivery of basic services;

WHEREAS, pursuant to Sections 22 and 444 of the Local Government Code of 1991, the Municipal Mayor may enter into contracts and agreements on behalf of the Municipality upon authority granted by the Sangguniang Bayan through an appropriate resolution;

WHEREAS, Barangay Bag-ong Argao has identified the procurement and installation of one (1) unit of 15 KVA transformer as an essential component of its Barangay Water System Project, the completion of which is necessary to ensure a reliable and sustainable water supply for the residents of the barangay;

WHEREAS, based on the cost estimate issued by ZAMSURECO I, the total project cost amounts to One Hundred Three Thousand Three Hundred Eighty-Five Pesos (P103,385.00), of which Thirty-Three Thousand Three Hundred Eighty-Five Pesos (P33,385.00) shall be sourced from Barangay Bag-ong Argao and transferred to the Municipal Government, while Seventy Thousand Pesos (P70,000.00) shall be provided by the Municipal Government of Molave as financial assistance;

WHEREAS, under the proposed Memorandum of Agreement, Barangay Bag-ong Argao shall act as the Source Agency while the Municipal Government of Molave shall serve as the Implementing Agency, thereby enabling the Municipality to undertake the procurement and installation of the transformer in accordance with applicable procurement laws, rules, and regulations;

WHEREAS, during the Committee deliberations, it was established that the previous implementation arrangement could not be immediately pursued because it

would have required the Barangay to conduct its own procurement process, resulting in unnecessary delay in the implementation of the project;

WHEREAS, considering that the procurement to be undertaken by the Municipal Government falls within the allowable threshold for Small Value Procurement, the proposed arrangement will facilitate the timely implementation of the project while ensuring compliance with Republic Act No. 12009, its Implementing Rules and Regulations, and other applicable procurement policies;

WHEREAS, the proposed Memorandum of Agreement clearly defines the respective responsibilities of the Source Agency and the Implementing Agency, including the lawful transfer and utilization of public funds, project implementation, financial reporting, monitoring, inspection, audit, and the refund of any unexpended balance, thereby promoting transparency, accountability, and proper stewardship of government resources in accordance with existing budgeting, accounting, and auditing rules and regulations;

WHEREAS, the Sangguniang Bayan previously enacted Resolution No. 12th-370-2026, authorizing the execution of a Memorandum of Agreement for the same Barangay Water System Project under a different implementation arrangement, wherein the Municipal Government served as the Source Agency and Barangay Bag-ong Argao served as the Implementing Agency;

WHEREAS, the newly proposed Memorandum of Agreement supersedes the previous arrangement by designating Barangay Bag-ong Argao as the Source Agency and the Municipal Government of Molave as the Implementing Agency, making it necessary to repeal Resolution No. 12th-370-2026 to avoid conflicting authorities and to ensure the proper implementation of the project;

WHEREAS, the august body found the proposed Memorandum of Agreement to be in order and recommended its approval;

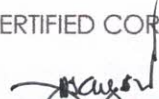
WHEREAS, that Resolution No. 12th-370-2026 is hereby repealed for having been superseded by the Memorandum of Agreement authorized under this Resolution.

NOW, THEREFORE, on motion of Honorable Orbita and duly seconded by Honorable Uy, the Sangguniang Bayan of Molave, Zamboanga del Sur, hereby;

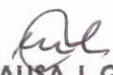
RESOLVED, as it is hereby resolved to authorize the Municipal Mayor, Hon. Cyril Reo A. Glepa, M.D., to enter into and sign a Memorandum of Agreement between the Municipal Government of Molave, as the Implementing Agency, and Barangay Bag-ong Argao, represented by its Punong Barangay, Hon. Marissa A. Pantinople, as the Source Agency, for the procurement and installation of One (1) unit of 15 KVA Transformer for the Barangay Water System Project, and repealing Resolution No. 12th-370-2026.

UNANIMOUSLY APPROVED, this 21st day of July, 2026 at Barangay Dontulan, Molave, Zamboanga del Sur.
