RESOLUTION NO. 12th-488-2026

A RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR, HON. CYRIL REO A. GLEPA, M.D., TO ENTER INTO AND SIGN A CONTRACT OF SERVICE WITH MR. JOHN RYAN N. BANZON, AS HAIR AND MAKE UP ARTIST AND PAGEANT COACH FOR THE MUNICIPALITY'S CANDIDATES FOR THE MR. & MISS ZAMBOANGA DEL SUR PROVINCIAL GOVERNMENT COLLEGE PAGEANT IN RELATION TO THE 74TH ARAW NG ZAMBOANGA DEL SUR CELEBRATION.

WHEREAS, the Province of Zamboanga del Sur will celebrate its 74th Araw ng Zamboanga del Sur, featuring various programs, activities, and competitions intended to promote the province's culture, talents, beauty, creativity, unity, and community participation;

WHEREAS, the Local Government Unit of Molave recognizes the importance of actively participating in the said celebration and showcasing the talents, personality, confidence, and skills of its constituents in the various provincial activities;

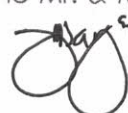
WHEREAS, one of the major activities in connection with the celebration is the Mr. & Miss Zamboanga del Sur – Provincial Government College (PGC) Pageant, wherein the Municipality of Molave shall participate through its official candidates;

WHEREAS, the participation of the Municipality's candidates requires specialized services in hair and makeup, styling, wardrobe coordination, pageant coaching, fitness and beauty preparation, and other related preparations to ensure that the candidates are properly prepared for the various pageant activities and exposures;

WHEREAS, Mr. John Ryan N. Banzon has been identified and evaluated as possessing the appropriate skills, experience, competence, and capability to provide the necessary hair and makeup artistry, styling, pageant coaching, and related services for the Municipality's candidates;

WHEREAS, the engagement of Mr. Banzon is necessary to provide professional assistance and guidance to the Municipality's candidates in their preparation and participation in the various activities and requirements of the Mr. & Miss Zamboanga del Sur – PGC Pageant;

WHEREAS, during deliberation, the august body reviewed the proposed Contract of Service (COS) and identified the appropriate duties, responsibilities, terms, and conditions to be undertaken by both parties to be in order, reasonable, and consistent with the objectives and requirements of the Municipality's participation in the Mr. & Miss Zamboanga del Sur – PGC Pageant;

WHEREAS, in consideration of the services to be rendered, the Municipality shall pay Mr. John Ryan N. Banzon the amount of ONE HUNDRED SEVENTY-FIVE THOUSAND PESOS (P175,000.00), payable in accordance with the terms of the Contract of Service and subject to compliance with all pertinent documentary, accounting, auditing, and other government requirements;

NOW, THEREFORE, on motion of Honorable Orbita and duly seconded by Honorable Uy, the Sangguniang Bayan of Molave, Zamboanga del Sur, hereby;

RESOLVED, as it is hereby resolved to authorize the Municipal Mayor, Hon. Cyril Reo A. Glepa, M.D., to enter into and sign a Contract of Service with Mr. John Ryan N. Banzon, as Hair and Make-Up Artist and Pageant Coach for the Municipality's Candidates for the Mr. & Miss Zamboanga del Sur Provincial Government College Pageant in relation to the 74th Araw ng Zamboanga del Sur Celebration.

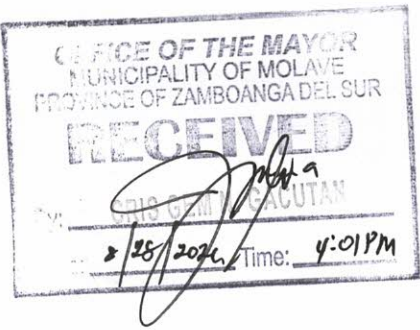
