RESOLUTION NO. 12<sup>th</sup>-485-2026

**A RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR, HON. CYRIL REO A. GLEPA, M.D., TO ENTER INTO AND SIGN A CONTRACT OF SERVICE WITH MR. KIRSCYN JOHN N. PACONG-HEAD CHOREOGRAPHER FOR THE MUNICIPALITY’S ENTRY TO THE 2026 ZAYAW SA SUR STREETDANCE COMPETITION IN RELATION TO THE 74<sup>TH</sup> ARAW NG ZAMBOANGA DEL SUR CELEBRATION.**

WHEREAS, the Province of Zamboanga del Sur will celebrate its 74th Araw ng Zamboanga del Sur, featuring various activities and competitions intended to promote the province's culture, talents, unity, sportsmanship, and community participation;

WHEREAS, the Local Government Unit of Molave recognizes the importance of actively participating in the said celebration, particularly in the 2026 Zayaw sa Sur Streetdance Competition, as an opportunity to showcase the talents, creativity, cultural heritage, and artistic excellence of the Municipality and its constituents;

WHEREAS, the Municipality's participation in the said competition requires the services of a qualified and experienced Head Choreographer who will be responsible for the conceptualization, development, training, coordination, and overall preparation of the Municipality's official entry;

WHEREAS, Mr. Kircsyn John N. Pacong has been identified and evaluated by the concerned office of the Local Government Unit as possessing the appropriate skills, experience, technical competence, and capability necessary to perform the duties and responsibilities of a Head Choreographer for the Municipality's entry to the 2026 Zayaw sa Sur Streetdance Competition;

WHEREAS, the engagement of Mr. Pacong is necessary to ensure the proper preparation, training, coordination, and presentation of the Municipality's participants and to enable the Municipality to comply with the prescribed mechanics, guidelines, and requirements of the competition;

WHEREAS, the proposed engagement is temporary and specific in nature and shall be limited to the provision of specialized choreographic, training, and related services necessary for the Municipality's participation in the 2026 Zayaw sa Sur Streetdance Competition;

WHEREAS, during deliberation, the committee identified the following obligations on the pro forma COS;

A. Obligations of the First Party:

- 1. To coordinate with the event organizers and provide instructions to the Second Party and ensure changes and updates regarding the activities are relayed as soon as available;
  - 2. To pay the Second Party the amount of One Hundred Seventy-Three Thousand (Php 173,000.00) in Philippine Currency, in split payment, first, on September 3, 2026 and second upon compliance of the Second Party of all requirements of the pertinent rules of service.
- B. Obligations of the Second Party:
- 1. Shall provide services as the head choreographer for the municipality's entry to the Zayaw sa Sur Street dance competition;
  - 2. To create and original dance routine for the participants that is aligned to the guidelines and mechanics of the competition;
  - 3. To conduct regular practice sessions and ensure all participants are rady and able to perform during the contest schedule;
  - 4. To provide for the Costume and Props requirements of all dancers during the night of the competition;
  - 5. To be available for the services required and adhere to the schedule agreed upon by the parties;
  - 6. To carry out the above services with utmost professionalism, skill and diligence;
  - 7. To pay the appropriate tax required of him under COA's rules and regulations

WHEREAS, the Sangguniang Bayan recognizes that the engagement of a qualified Head Choreographer is necessary and beneficial to the Municipality's effective participation in the said competition and contributes to the promotion of local talent, culture, creativity, and pride of place; further, that the provisions, terms, and conditions of the proposed Contract of Service have been found to be in order, reasonable, and consistent with the purpose and requirements of the Municipality's participation in the 2026 Zayaw sa Sur Streetdance Competition;

NOW, THEREFORE, on motion of Honorable Orbita and duly seconded by Honorable Salinas, the Sangguniang Bayan of Molave, Zamboanga del Sur, hereby;

RESOLVED, as it is hereby resolved to authorize the Municipal Mayor, Hon. Cyril Reo A. Glepa, M.D., to enter into and sign a Contract of Service with Mr. Kircsyn John N. Pacong- Head Choreographer for the municipality's entry to the 2026 Zayaw sa Sur Streetdance Competition in relation to the 74<sup>th</sup> Araw ng Zamboanga del Sur celebration.

UNANIMOUSLY APPROVED, this 25<sup>th</sup> day of August, 2026 at Molave, Zamboanga del Sur.

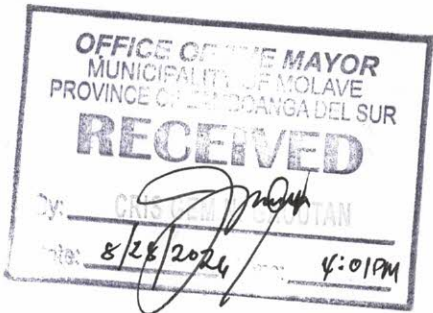
